\*Cannabis is difficult to detect in hair at low levels. Our standard panel test, **as with all other UK providers**, will not detect low use. We therefore provide a more sensitive Cannabis (THC-COOH) test, exclusive to ScreenSafe UK, which **will detect Cannabis use at very low levels**. If in doubt which test to choose, please call for advice.

\*\*As recommended by High Court ruling. Note: ETG & FAEE can only be carried out on head hair and must be in 3cm segments (1x3cm, 2x3cm etc). If your client has less than 3cm of head hair, no head hair at all, or you require segmented analysis to show patterns of use [exclusive to ScreenSafe UK] – choose the Alcohol (ETG) analysis.

\*\*\* The standard Benzodiazepines Group 1 test is “like for like” with all other UK suppliers to help you compare prices. A “negative” result from this test may not actually be truly negative for Benzodiazepines (and can therefore be open to challenge). We therefore also offer a test for a wider range of Benzodiazepines that will be missed by other suppliers. These are our Benzodiazepines (Group 2). ### SAMPLE LENGTH DETAILS (TICK ONE BOX)

Drug use can be identified from one to several months depending on the length of hair. 1cm centimetre section of hair represents approximately one month's growth. Thus, to determine average drug usage over the past three months, a 3cm sample of hair would be required and so on. Hair can be taken from other parts of the body and analysed, but only head hair can be segmented for more detailed results.

A 1cm section approximates one month's hair growth. A 3cm section approximates three months hair growth etc. Thus, an analysis of ONE x '3cm' section (option “d” below) will provide an average level of intake over the preceding twelve-week period. If the same 3cm sample was sectionalised into THREE x '1cm' sections (option “c” below), this will provide an average intake for EACH of the preceding four-week periods giving a far more detailed history. This needs to be considered when establishing an individual's trend history – either decreasing or increasing.
